In mid-October all 17 members of IAFF Local 2567 filed a vote of no confidence in Jenks Fire and Rescue Chief Gary Friedel. As the fire fighters filed their grievances in a manner determined unlawful per their contract, Jenks City Council authorized the City Attorney to file an unfair labor practice complaint against the IAFF Local 2567 with the Oklahoma Public Employees Relations Board.

# Council comes to decision in fire department issue

Jenks City Council voted to authorize the city attorney to file an unfair labor practice complaint against the IAFF Local 2567 with the Oklahoma Public Employee Relations Board. According to Mayor Lonnie Sims at this time the city has no intention to file a claim.

The city council issue began when all 17 members of IAFF Local 2567 filed a vote of no confidence against Jenks Fire and Rescue Chief Gary Friedel for the regularly scheduled Oct. 21 city council meeting.

During that meeting it was presented the IAFF Local 2567 had gone through improper avenues of filing grievances against the chief. Council members voted, during the Oct. 21 meeting, to request more information from the fire fighters

member to vote no, stating he felt filing a suit was an improper response. Other council members expressed their vote of "yes" came as a result of concerns as to setting precedence to let employees behave in an unlawful manner.

"I think this puts [the issue] to bed." Sims told the South County Leader after the meeting. "The vote gives us the option to file a claim, but we have no intentions to do so at this point.

"This was an open dialogue to hear the firefighters concerns and let the chief respond, and I think we've done that. We are confident in both our firemen and our chief to move forward appropriately."

"I am very thankful council provided me an opportunity to share information about the status of our department and appreciate their valuable time on this important matter," Friedel told the South County Leader. "Now it's time for our de-

and give Friedel a chance to respond.

On Nov. 4, council members discussed the issue in executive session and came back with no vote. Council proceeded to vote yes to agenda item No. 27, "request to authorize the city attorney to file an unfair labor practice complaint against IAFF Local 2567 with the Oklahoma Public Employees Relations Board," in regards to the IAFF filing their grievances in an unlawful manner.

Councilman Mike Sharp was the only

"I am both optimistic about our future and hopeful this matter is behind us. It is an honor to continue serving this excellent community."
