

Using Timelines to Analyze Your Research

Timelines are a great research and analysis tool every genealogist should know how to use. A chronological look at the events in an ancestor's life can answer many research questions. Timelines can focus on the whole lifespan of an individual or focus on important events that happened in a particular place. Timelines are an important tool for visualizing our ancestors' lifetimes, giving context to their actions.

What are Timelines?

Typically, timelines are chronological lists of events relating to a topic, usually for a person, a period in time, or a location. Timelines can be created in a number of different ways, organized by different topics, and displayed in a variety of forms.

Timelines for individuals can be organized by life events or by documents collected. They can include historical events to give context to personal events. Genealogy software, standard word processing or spreadsheets, specialized timeline software or websites, or even plain old pencil and paper can be used to create timelines.

Timeline Tips for Analysis

When creating your timelines for use as analysis tools, there are a few things you can do to make them more useful:

- Color code the data by county, state, or country to indicate a change in location
- Include citations so you know where the information came from
- Add items of historical or local importance for context
- Include: date, age at event, type of event, location of event (state, city), and source
- Create two timelines side-by-side in order to compare two individuals to determine if they are two people of the same name, or one person.

Once you've created your timeline, you can begin to look for gaps in time that need more research. Try to locate one document for every year of your ancestor's life. This may or may not

be possible, but by working toward that goal, many research questions can be answered. When examining your timeline, ask:

- Where (when) are there gaps in the timeline?
- What records might fill those gaps?
- What historical events were happening during those time gaps? Nationally? Statewide? Locally?

For more context, trying adding information on:

- Changes in county boundaries
- Changes in state or federal laws
 - ➡ Homestead Act
 - ➡ Various tax laws
 - ➡ Dower Rights
 - → Age to enlist, marry without parental consent, serve on a jury, etc.
- Catastrophic events affecting the area and/or the records
 - → Fire, Flood Courthouses
 - → Hurricanes, Tornadoes
 - → Major accidents trains, planes, automobiles, farming, mining, shipping
 - → Wars, local battles

Resources for Historical Timelines

Utilize your favorite search engine to help locate a historical timeline for the location and timeframe you are working in. It is likely that a general timeline has already been compiled and published online that you can use to fill in your timeline to give your ancestor's life context. Try searching for "Texas historical timeline" or use the state,

county, or city, and/or event of your choice, to examine timelines available. Here are some example timelines of historical events:

- Texas State Historical Association, Texas Almanac "Timeline of Texas History"
- Arkansas Secretary of State "Arkansas History Timeline"

A favorite quick-reference guide is *The Genealogist's U.S. History Pocket Reference* by Nancy Hendrickson. This is a great little book full of dates and facts of historical significance.

Ways to Create a Timeline

There are a lot of different ways one could create a timeline. Most often a simple one is sufficient for analysis. Try using a word processor or spreadsheet for the easiest ways to create, manipulate, and rearrange your data. Spreadsheets have the advantage of being easily sorted by column so that you can sort your data by chronology, but you can also group the data by other types such as record type, event, location, and anything else you decide to include.

Many genealogy programs on the market today have reports that you can run to create a timeline based on your data. Each program might have different features. Some may include any photos or images you attached, whereas other may indicate the individual's age at the time of the event. Some reports can be run on multiple individuals so that you can see how their lifespans overlapped.

There are also a number of software and website sources for creating timelines. Some are drawing programs with timeline

templates, while others are specifically for timeline creation. If you'd like to try a more robust or graphic representation for your timeline, you may want to look at some of the following:
